# Stage Play Production Agreement

This Agreement is made and entered into as of [Date], by and between:

## 1. Purpose of Agreement

The purpose of this agreement is to set forth the terms and conditions under which the Producer will provide theatrical production services to the Client.

# 2. Stage Play Selection

Client shall choose one (1) of the following original stage plays to be written, directed, and produced by 2W Productions:1. Beauty in the Hood2. Office Accounts3. F.L.E.S.H.Client must notify Producer of selection in writing at least 60 days prior to the scheduled production date.

## 3. Producer Responsibilities

2W Productions shall:- Write or adapt the chosen play- Direct and oversee all aspects of production- Produce the play including script, creative vision, and stage management- Facilitate and conduct casting auditions- Provide rehearsal direction and production oversight

## 4. Client Responsibilities

The Client agrees to:- Provide a suitable venue for the performance(s) with all necessary stage and technical accommodations- Conduct marketing and promotions for the production- Obtain and maintain all required event insurance- Announce and support the casting call using its community networks and platforms- Cover all venue-related costs- Provide technical assistance including lighting, sound, and stage crew

#### 5. Compensation

The Client agrees to compensate the Producer as follows (choose one):Option A: Upfront Payment- Fee: \$[Insert Amount]- Due: In full within 15 days of agreement signing- This option includes a 10% discount off the total production fee.Option B: Deferred Payment- Fee: \$[Insert Higher Amount]- Due: Within 7 days after the final performance- This option includes an increased fee to cover delayed payment.\*Client must confirm selected payment option in writing.\*

#### 6. Term & Cancellation

This Agreement shall remain in effect from the date of execution until the completion of the final performance, unless terminated earlier by mutual written agreement. Either party may cancel this agreement with at least 30 days' written notice. If canceled by the Client after work has begun, the Client agrees to pay for all work completed up to the date of termination.

#### 7. Intellectual Property

All scripts, stage direction, and creative content remain the sole property of 2W Productions. Client may not reproduce, alter, or distribute materials without written permission.

# 8. Indemnity

Each party agrees to indemnify and hold the other harmless from any claims, damages, or liabilities arising from their respective responsibilities under this Agreement.

# 9. Miscellaneous

This Agreement constitutes the entire agreement between the parties.- Any amendments must be made in writing and signed by both parties.- This Agreement shall be governed by the laws of the State of [Insert State].
